



## REQUEST FOR BIDS (RFB)

1. This Request for Bids follows the General Procurement Notice/Advanced Procurement Notice for this purchase that appeared in:
  - a. Sunday Observer on 21 June 2026
  - b. Silumina on 21 June 2026
2. The Chairman Department Procurement Committee (DPC) on behalf of the Sri Lanka Air Force now invites sealed bids/proposals from eligible and qualified bidders for Annual Contract for the Obtaining of Janitorial Service for the AFHQ SJP .
3. **The delivery period is.**
  - a. **The service should be commenced after signing the contract agreement.**
4. Bidding will be conducted through National Competitive Bidding (NCB).
5. **Qualifications requirements include:**
  - a. Documents specified in eligibility and qualification requirements specified in Section V.
  - b. A margin of preference for eligible locally produced Services shall not be applied.
6. **A complete set of Procurement Documents in English** may be purchased by interested bidders:
  - a. Upon submission of a written request to the address given in para 12 above.
  - b. Upon payment of a non-refundable fee of LKR **1000.00** to the Director Finance of the Sri Lanka Air Force at (SLAF) the address given in para 12.
  - c. **Method of payment:** By cash.

7. Bids addressed to the Chairman Department Procurement Committee (DPC) must be delivered to the address mentioned in para 12.
- a. **Bids** should only be **hand delivered, sent via registered post or couriered.**
  - b. **Emailed bids** and bids sent via fax **will not be accepted.**
  - c. Late bids shall be rejected.
  - d. Bids/proposals will be opened at 1030 hrs on 14 July 2026 in the presence of bidders' representatives (in-person or virtually) at the address given in para 12 above.
8. All bids must include a **Bid-Security for the value of LKR 36,000.00, validity date until 29 Sep 2026.**
9. If stated in the Data Sheet the Bidder shall submit a certificate from the manufacturer to demonstrate that it has been duly authorized by the manufacturer or producer of the services to supply these services in Sri Lanka.
10. If the testing charges / samples are required by the Bidding Document (Please refer Section IV) the relevant conditions given in the Bidding Document shall be complied with in all respects without any reservation. The original cash receipt for testing charges issued by the Director Finance of the SLAF shall be attached to the original bid.
11. The successful bidder shall undertake to perform the resulting order/ contract with all-reasonable skill, diligence and care in accordance with sound industry practice to the satisfaction of the SLAF and accept full responsibility for the satisfactory quality of such services as delivered /performed by them. Any non-conformity/ malfunction/ defect/ deficiency noticed in the services rendered shall be promptly remedied by the successful bidder upon the receipt of written notice from the SLAF.

# SECTION I. INSTRUCTIONS TO BIDDERS (ITB)

ITB shall be read in conjunction with the Section II, Bidding Data Sheet (BDS), which shall take precedence over ITB.

<b>GENERAL</b>	<b>1. Scope of Bid</b>	<p>1.1 The Purchaser indicated in the Bidding Data Sheet (BDS), issues these Bidding Documents for the supply of Related Services incidental thereto as specified in Section V, Schedule of Requirements. The name and identification number of this procurement are specified in the BDS. The name, identification, and number of lots (individual contracts), if any, are provided in the BDS.</p> <p>1.2 Throughout these Bidding Documents:</p> <p>(a) the term “in writing” means communicated in written form by mail (other than electronic mail) or hand delivered with proof of receipt;</p> <p>(b) if the context so requires, “singular” means “plural” and vice versa; and</p> <p>(c) “day” means calendar day.</p>
	<b>2. Source of Funds</b>	<p>2.1 Payments under this contract will be financed by the source specified in the BDS.</p>
	<b>3. Ethics, Fraud and Corruption</b>	<p>3.1 The attention of the bidders is drawn to the following guidelines of the Procurement Guidelines published by National Procurement Agency: - Parties associated with Procurement Actions, namely, suppliers/contractors and officials shall ensure that they maintain strict confidentiality throughout the process;</p> <p>- Officials shall refrain from receiving any personal gain from any Procurement Action. No gifts or inducement shall be accepted. Suppliers/contractors are liable to be disqualified from the bidding process if found offering any gift or inducement which may have an effect of influencing a decision or impairing the objectivity of an official.</p> <p>3.2 The Purchaser requires the bidders, suppliers, contractors, and consultants to observe the highest standard of ethics during the procurement and execution of such contracts. In pursuit of this policy:</p>

Eligible Bidders</b></p>	<p>4.1 All bidders shall possess legal rights to supply the services under this contract. 4.2 A Bidder shall not have a conflict of interest. All bidders found to have conflict of interest shall be disqualified. Bidders may be considered to have a conflict of interest with one or more parties in this bidding process, if they:</p> <p>(a) are or have been associated in the past, with a firm or any of its affiliates which have been engaged by the Purchaser to provide consulting services for the preparation of the design, specifications, and other documents to be used for the procurement of the services to be purchased under these Bidding Documents; or</p> <p>(b) submit more than one bid in this bidding process. However, this does not limit the participation of subcontractors in more than one bid.</p>

		<p>4.3 A Bidder that is under a declaration of ineligibility by the National Procurement Agency (NPA), at the date of submission of bids or at the date of contract award, shall be disqualified. The list of debarred firms is available at the website of NPA, <a href="http://www.npa.gov.lk">www.npa.gov.lk</a>.</p> <p>4.4 Foreign Bidder may submit a bid only if so stated in the BDS.</p>
<b>ELIGIBLE RELATED SERVICES</b>	<b>5. Eligible Related Services</b>	<p>5.1 All services supplied under this contract shall be complied with applicable standards stipulated by the Sri Lanka Standards Institute (SLSI). In the absence of such standards, the services supplied shall be complied to other internationally accepted standards.</p>
<b>CONTENTS OF BIDDING DOCUMENTS</b>	<b>6. Sections of Bidding Documents</b>	<p>6.1 The Bidding Documents consist of 2 Volumes, which include all the sections indicated below, and should be read in conjunction with any addendum issued in accordance with ITB Clause 8.</p> <p><b>VOLUME 1</b>  Section I. Instructions to Bidders (ITB)  Section VI. Conditions of Contract (CC)  Section VIII. Contract Forms</p> <p><b>VOLUME 2</b>  Section II. Bidding Data Sheet (BDS)  Section III. Contract Data  Invitation for Bid</p> <p>6.2 The Bidder is expected to examine all instructions, forms, terms, and specifications in the Bidding Documents. Failure to furnish all information or documentation required by the Bidding Documents may result in the rejection of the bid.</p>
<b>CLARIFICATION AND AMENDMENT</b>	<b>7. Clarification of Bidding Documents</b>	<p>7.1 A prospective Bidder requiring any clarification of the Bidding Documents including the restrictiveness of specifications shall contact the Purchaser in writing at the Purchaser's address specified in the BDS. The Purchaser will respond in writing to any request for clarification, provided that such request is received no later than ten (10) days prior to the deadline for submission of bids. 		response to all those who have purchased the Bidding Documents, including a description of the inquiry but without identifying its source. Should the Purchaser deem it necessary to amend the Bidding Documents as a result of a clarification, it shall do so following the procedure under ITB Clause 8.
	<b>8. Amendment of Bidding Documents</b>	<p>8.1 At any time prior to the deadline for submission of bids, the Purchaser may amend the Bidding Documents by issuing addendum.</p> <p>8.2 Any addendum issued shall be part of the Bidding Documents and shall be communicated in writing to all who have purchased the Bidding Documents.</p> <p>8.3 To give prospective Bidders reasonable time in which to take an addendum into account in preparing their bids, the Purchaser may, at its discretion, extend the deadline for the submission of bids, pursuant to ITB Sub-Clause 23.2.</p>
<b>PREPARATION OF BIDS</b>	<b>9. Cost of Bidding</b>	9.1 The Bidder shall bear all costs associated with the preparation and submission of its bid, and the Purchaser shall not be responsible or liable for those costs, regardless of the conduct or outcome of the bidding process.
	<b>10. Language of Bid</b>	10.1 The Bid, as well as all correspondence and documents relating to the Bid (including supporting documents and printed literature) exchanged by the Bidder and the Purchaser, shall be written in English language.
	<b>11. Documents Comprising the Bid</b>	<p>11.1 The Bid shall comprise the following:</p> <p>(a) Bid Submission Form and the applicable Price Schedules, in accordance with ITB Clauses 12, 14, and 15;</p> <p>(b) Bid Security or Bid-Securing Declaration, in accordance with ITB Clause 20;</p> <p>(c) documentary evidence in accordance with ITB Clauses 18 and 29, that the Related Services conform to the Bidding Documents;</p> <p>(d) documentary evidence in accordance with ITB Clause 18 establishing the Bidder's qualifications to perform the contract if its bid is accepted; and</p> <p>(e) any other document required in the BDS.</p>

<b>BID SUBMISSION</b>	<b>12. Bid Submission Form and Price Schedules</b>	12.1 The Bidder shall submit the Bid Submission Form using the form furnished in Section IV, Bidding Forms. This form must be completed without any alterations to its format, and no substitutes shall be accepted. All blank spaces shall be filled in with the information requested.
	<b>13. Alternative Bids</b>	13.1 Alternative bids shall not be considered.
	<b>14. Bid Prices and Discounts</b>	<p>14.1 The Bidder shall indicate on the Price Schedule the unit prices and total bid prices of the services it proposes to supply under the Contract.</p> <p>14.2 Any discount offered against any single Services in the price schedule shall be included in the unit price of the Services. However, a Bidder wishes to offer discount as a lot the bidder may do so by indicating such amounts appropriately.</p> <p>14.3 If so indicated in ITB Sub-Clause 1.1, bids are being invited for individual contracts (lots) or for any combination of contracts (packages). Unless otherwise indicated in the BDS, prices quoted shall correspond to 100 % of the Services specified for each lot and to 100% of the quantities specified for each Services of a lot. A bid submitted with an adjustable price quotation will be treated as non-responsive and rejected, pursuant to ITB Clause 31.</p> <p>14.6 All lots, if any, and Services must be listed and priced separately in the Price Schedules. If a Price Schedule shows Service listed but not priced, their prices shall be assumed to be included in the prices of other Services.</p>
	<b>15. Currencies of Bid</b>	15.1 Unless otherwise stated in Bidding Data Sheet, the Bidder shall quote in Sri Lankan Rupees and payment shall be payable only in Sri Lanka Rupees.
	<b>16. Documents Establishing the Eligibility of the Bidder</b>	16.1 To establish their eligibility in accordance with ITB Clause 4, Bidders shall complete the Bid Submission Form, included in Section IV, Bidding Forms.
	<b>17. Documents Establishing the Conformity of the Related Services</b>	<p>17.1 To establish the conformity of the Related Services to the Bidding Documents, the Bidder shall furnish as part of its Bid the documentary evidence that the services conform to the technical specifications and standards specified in Section V, Schedule of Requirements.</p> <p>17.2 The documentary evidence may be in the form of literature, drawings or data, and shall consist of a detailed Services by Services description (given in Section V, Technical Specifications) of the essential technical and performance characteristics of the Related Services, demonstrating substantial responsiveness of the Related Services to the technical specification, and if applicable, a statement of deviations and exceptions to the provisions of the Schedule of Requirements.</p> <p>17.3 The Bidder shall also furnish a list giving full particulars, including quantities, available sources and current prices of spare parts, special tools, etc., necessary for the proper and continuing functioning of the services during the period if specified in the BDS following commencement of the use of the services by the Purchaser.</p>

	<p><b>Qualifications of the Bidder</b></p>	<p>is accepted shall establish to the Purchaser's satisfaction:</p> <p>(a) A Bidder that does not manufacture or produce the services it offers to supply shall submit the Manufacturer's Authorization using the form included in Section IV, Bidding Forms to demonstrate that it has been duly authorized by the manufacturer or producer of the services to supply these services;</p> <p>(b) that, if required in the BDS, in case of a Bidder not doing business within Sri Lanka, the Bidder is or will be (if awarded the contract) represented by an Agent in Sri Lanka equipped and able to carry out the Supplier's maintenance, repair and spare parts stocking obligations prescribed in the Conditions of Contract and/or Technical Specifications; and</p> <p>(c) that the Bidder meets each of the qualification criterion specified in Section III, Evaluation and Qualification Criteria.</p>

A bid valid for a shorter date shall be rejected by the Purchaser as non-responsive.</p> <p>19.2 In exceptional circumstances, prior to the expiration of the bid validity date, the Purchaser may request bidders to extend the period of validity of their bids. The request and the responses shall be made in writing. If a Bid Security is requested in accordance with ITB Clause 20, it shall also be extended for a corresponding period. A Bidder may refuse the request without forfeiting its Bid Security. A Bidder granting the request shall not be required or permitted to modify its bid.</p>

	<p><b>21. Format and Signing of Bid</b></p>	<p>21.1 The Bidder shall prepare one original of the documents comprising the bid as described in ITB Clause 11 and clearly mark it as “ORIGINAL.” In addition, the Bidder shall</p>

		<p>submit a copy of the bid and clearly mark it as “COPY.” In the event of any discrepancy between the original and the copy, the original shall prevail.</p> <p>21.2 The original and the Copy of the bid shall be typed or written in indelible ink and shall be signed by a person duly authorized to sign on behalf of the Bidder.</p> <p>21.3 Any interlineations, erasures, or overwriting shall be valid only if they are signed or initialled by the person signing the Bid.</p>
<b>SUBMISSION AND OPENING OF BIDS</b>	<b>22. Submission, Sealing and Marking of Bids</b>	<p>22.1 Bidders may always submit their bids by mail or by hand. (a) Bidders submitting bids by mail or by hand, shall enclose the original and the copy of the Bid in separate sealed envelopes, duly marking the envelopes as “ORIGINAL” and “COPY.” These envelopes containing the original and the copy shall then be enclosed in one single envelope.</p> <p>22.2 The inner and outer envelopes shall:</p> <p>(a) Bear the name and address of the Bidder;</p> <p>(b) be addressed to the Purchaser in accordance with ITB Sub-Clause 23.1;</p> <p>(c) bear the specific identification of this bidding process as indicated in the BDS; and</p> <p>(d) bear a warning not to open before the time and date for bid opening, in accordance with ITB Sub-Clause 26.1.</p> <p>If all envelopes are not sealed and marked as required, the Purchaser will assume no responsibility for the misplacement or premature opening of the bid.</p>

	<b>24. Late Bids</b>	<p>24.1 The Purchaser shall not consider any bid that arrives after the deadline for submission of bids, in accordance with ITB Clause 23. Any bid received by the Purchaser after the deadline</p>

		<p>for submission of bids shall be declared late, rejected, and returned unopened to the Bidder.</p>
	<p><b>25. Withdrawal, and Modification of Bids</b></p>	<p>25.1 A Bidder may withdraw, or modify its Bid after it has been submitted by sending a written notice in accordance with ITB Clause 22, duly signed by an authorized representative, and shall include a copy of the authorization in accordance with ITB Sub-Clause 21.2, (except that no copies of the withdrawal notice are required). The corresponding substitution or modification of the bid must accompany the respective written notice. Bid Opening</b></p>	<p>26.1 The Purchaser shall conduct the bid opening in public at the address, date and time specified in the BDS.</p> <p>26.2 First, envelopes marked “WITHDRAWAL” shall be opened and read out and the envelope with the corresponding bid may be opened at the discretion of the Purchaser. No bid withdrawal shall be permitted unless the corresponding withdrawal notice contains a valid authorization to request the withdrawal and is read out at bid opening. Envelopes marked “MODIFICATION” shall be opened and read out with the corresponding Bid. No Bid modification shall be permitted unless the corresponding modification notice contains a valid authorization to request the modification and is read out at Bid opening. Only envelopes that are opened and read out at Bid opening shall be considered further.</p>

		<p>26.3 All other envelopes shall be opened one at a time, reading out: the name of the Bidder and whether there is a modification; the Bid Prices, including any discounts and alternative offers; the presence of a Bid Security or Bid-Securing Declaration, if required; and any other details as the Purchaser may consider appropriate. Only discounts and alternative offers read out at Bid opening shall be considered for evaluation. Confidentiality</b></p>	<p>27.1 Information relating to the examination, evaluation, comparison, and post-qualification (if applicable) of bids, and recommendation of contract award, shall not be disclosed to bidders or any other persons not officially concerned with such process until publication of the Contract Award.</p> <p>27.2 Any effort by a Bidder to influence the Purchaser in the examination, evaluation, comparison, and post-qualification of the bids or contract award decisions may result in the rejection of its Bid.</p> <p>27.3 Notwithstanding ITB Sub-Clause 27.2, if any Bidder wishes to contact the Purchaser on any matter related to the bidding process, from the time of bid opening to the time of Contract Award, it should do so in writing.</p>
	<p><b>28. Clarification of Bids</b></p>	<p>28.1 To assist in the examination, evaluation, comparison and post-qualification of the bids, the Purchaser may, at its discretion, request any Bidder for a clarification of its Bid. Any clarification submitted by a Bidder in respect to its Bid and that is not in response to a request</p>

		<p>by the Purchaser shall not be considered for purpose of evaluation. The Purchaser's request for clarification and the response shall be in writing. No change in the prices or substance of the Bid shall be sought, offered, or permitted, except to confirm the correction of arithmetic errors discovered by the Purchaser in the Evaluation of the bids, in accordance with ITB Clause 30.</p>
	<p><b>29. Responsiveness of Bids</b></p>	<p>29.1 The Purchaser's determination of a bid's responsiveness is to be based on the contents of the bid itself.</p> <p>29.2 A substantially responsive Bid is one that conforms to all the terms, conditions, and specifications of the Bidding Documents without material deviation, reservation, or omission. 4. **Documentation Required.** Bidders must submit:
- a. Proof of legal registration (business license, tax certificates).
  - b. Audited financial statements (last 3 years, if applicable).
  - c. Experience records (similar projects completed).
  - d. Declaration of non-debarment and compliance with sanctions.

### **3. SPECIFICATIONS**

#### **1. Contract Period**

a. The service shall be provided for a period of one (01) year, from 01 August 2026 to 31 July 2027.

b. The Service Provider shall commence services only after signing the agreement, submitting all required securities/documents and receiving written clearance from the Service Recipient.

#### **2. Manpower and Deployment Requirements**

a. The number of labourers deployed for service on each working day shall be Eight (08), consisting of Six (06) Male labourers and two (02) Female labourers.

b. One (01) dedicated Working Supervisor shall be physically available on-site at all times to maintain and attendance register, task allocation record, check list on quality of the service, material issued record, discipline of the staff and compliance with SLAF instructions in liaison with SLAF representative.

c. The Service Provider shall not deploy personnel who are of advanced age medically unfit, physically incapable, under the influence of liquor/intoxicants or otherwise unsuitable to perform duties in a defence establishment.

d. The Service Provider shall submit copies of National Identity Card, Police Report, Grama Niladari Certificate, security clearance details deemed necessary related to all personnel prior to deployment. Further, replacement personnel shall not be deployed without prior approval of the Service Recipient.

e. Attendance and Punctuality: All personnel shall report for duty by 0700 hrs unless otherwise directed in writing. Late arrival, early departure or absence shall be recorded as a service deficiency. Further if the required number of personnel is not reported for duty, the Service Provider shall provide a suitable replacement within three (03) hours. Failure to do so may result in proportionate deduction from the monthly bill and/or other contractual action.

f. Uniforms and Identification: All personnel shall wear clean, standard uniforms, compatible to a military headquarters environment and a valid identification passes issued by SLAF while on duty.

g. Conduct: Staff of the service provider shall be courteous, well disciplined and compliant with SLAF security terms, movement restrictions, administrative instructions, refrain from unauthorized photography and confidentiality on sharing verified information to any other party. Misconduct may result in immediate removal from the premises.

**3. Working Schedule**

- a. Standard Service: Services shall be provided three (03) days per week, preferably Monday, Wednesday and Friday, unless otherwise directed by the Service Recipient.
- b. Holiday Protocol: If a scheduled working day falls on a public holiday, the service shall be carried out on the next working day or on a mutually agreed alternative day.
- c. Monthly Requirement: A minimum of twelve (12) working days per month shall be maintained for the agreed base price.
- d. The Service Recipient may adjust the working days and reporting time due to official functions, inspections, VIP/VVIP movements, emergencies or operational requirements without altering the monthly minimum requirement unless additional service days are ordered.
- e. A separate five (05) working days per week option shall be quoted by bidders for price comparison and future administrative decision, but shall not be treated as the base requirement unless specifically awarded. Any special discount for five day service may be offered separately for special consideration.

**4. Scope of Cleaning Services**

- a. The Service Provider shall clean, dry, disinfect, deodorize and maintain all identified washrooms, toilets, urinals, sinks, floors, mirrors, doors in clean and dry condition within the areas allocated by the Service Recipient.
- b. Floors shall be swept, mopped, scrubbed, dried where required and kept free from dirt, stains, unpleasant odour, water stagnation and visible waste.
- c. Waste bins shall be emptied, cleaned and lined where applicable. Waste shall be removed only to the locations directed by the Service Recipient and shall not be disposed in unauthorized areas.
- d. The Service Provider shall immediately report blocked drains, damaged fittings, leakages, electrical hazards, pest activity, broken locks or any abnormal condition noticed during cleaning to the service recipient.

**5. Gender-Specific and Sensitive Area Cleaning**

- a. The Service Provider shall ensure that appropriate male and female personnel are available to clean both male and female washrooms without reluctance or disruption.
- b. Female washrooms shall be cleaned by female personnel and male washrooms by male personnel. Where operationally necessary or under exceptional situation

cleaning of either area shall be coordinated through the Supervisor and the nominated SLAF representative, ensuring privacy, dignity and security.

c. The Service Provider shall ensure that minimum two (02) female labourers reports on every scheduled working day unless prior written approval is obtained.

## 6. **Operational Obligations**

a. **Emergency Contact:** A designated 24/7 point of contact shall be provided to the Service Recipient for emergency requirements.

b. **Duty Integrity:** Personnel assigned to cleaning duties shall not be diverted to other tasks that interfere with their primary responsibilities.

c. **Security of Belongings:** The Service Provider shall ensure appropriate arrangements for staff to safeguard personal belongings while on duty with the facilities made available by the Service Recipient within the premises.

d. The Service Provider shall comply with all applicable labour laws, Employees' Provident Fund/Employees' Trust Fund requirements, minimum wage requirements, occupational safety obligations and other statutory requirements applicable in Sri Lanka.

e. The Service Provider shall ensure that deployed personnel do not solicit money, food, goods, favours, transport or private work from SLAF personnel.

## 7. **Materials, Consumables and Equipment**

a. Required cleaning materials shall be provided by the Service Provider and supplied in a timely manner. Any shortage affecting service standards shall be rectified immediately.

b. The Service Provider shall provide adequate, suitable toilet cleaner, disinfectant, floor cleaner, glass cleaner, deodorizer/air freshener, hand-wash/soap where required, garbage bags, scrub pads, brushes, mops, buckets, wipers, brooms, gloves, masks, caution/wet-floor signs and other consumables/equipment required for proper janitorial service.

c. All chemicals shall be safe for use in occupied office premises, properly labelled, non-damaging to sanitary fittings/floor surfaces and stored only in locations approved by the Service Recipient. Hazardous or corrosive substances shall not be used without prior approval.

d. **Equipment:** All necessary equipment shall be provided and maintained by the Service Provider. Defective, unsafe, unhygienic or unsuitable equipment shall be replaced immediately.

e. The cost of labour, supervision, uniforms, safety gear, consumables, tools, transport and equipment shall be included in the quoted rates unless expressly stated otherwise in the bidding document.

8. **Quality Control, Inspection and Acceptance of Service**

- a. The Service Recipient shall nominate an authorized SLAF representative to monitor the service, verify attendance and inspect completed work.
- b. A daily checklist shall be maintained by the Supervisor and countersigned by the nominated SLAF representative after inspection. Certification of the monthly bill shall be based on attendance, completion of tasks and service quality.
- c. Payment shall be subjected to satisfactory performance and completion of the required number of service days. Absence, shortage of manpower, lack of materials, poor cleaning, misconduct or non-compliance may result in proportionate deductions, warnings or termination as per the contract.
- d. The Service Recipient may conduct surprise inspections at any time for verification of service performance.

9. **Pricing and Bidding**

- a. Base Price: Bidders shall quote for the standard requirement of three (03) days per week with a minimum of twelve (12) service days per month.
- b. Five-Day Option: Costs for a five (05) day work week shall be quoted separately. Any discount for five day services shall be indicated separately for special consideration.
- c. The quoted rates shall be inclusive of all applicable costs, taxes, statutory payments, uniforms, supervision, consumables, equipment, transport, overheads and profit, unless the bidding document specifically provides otherwise.
